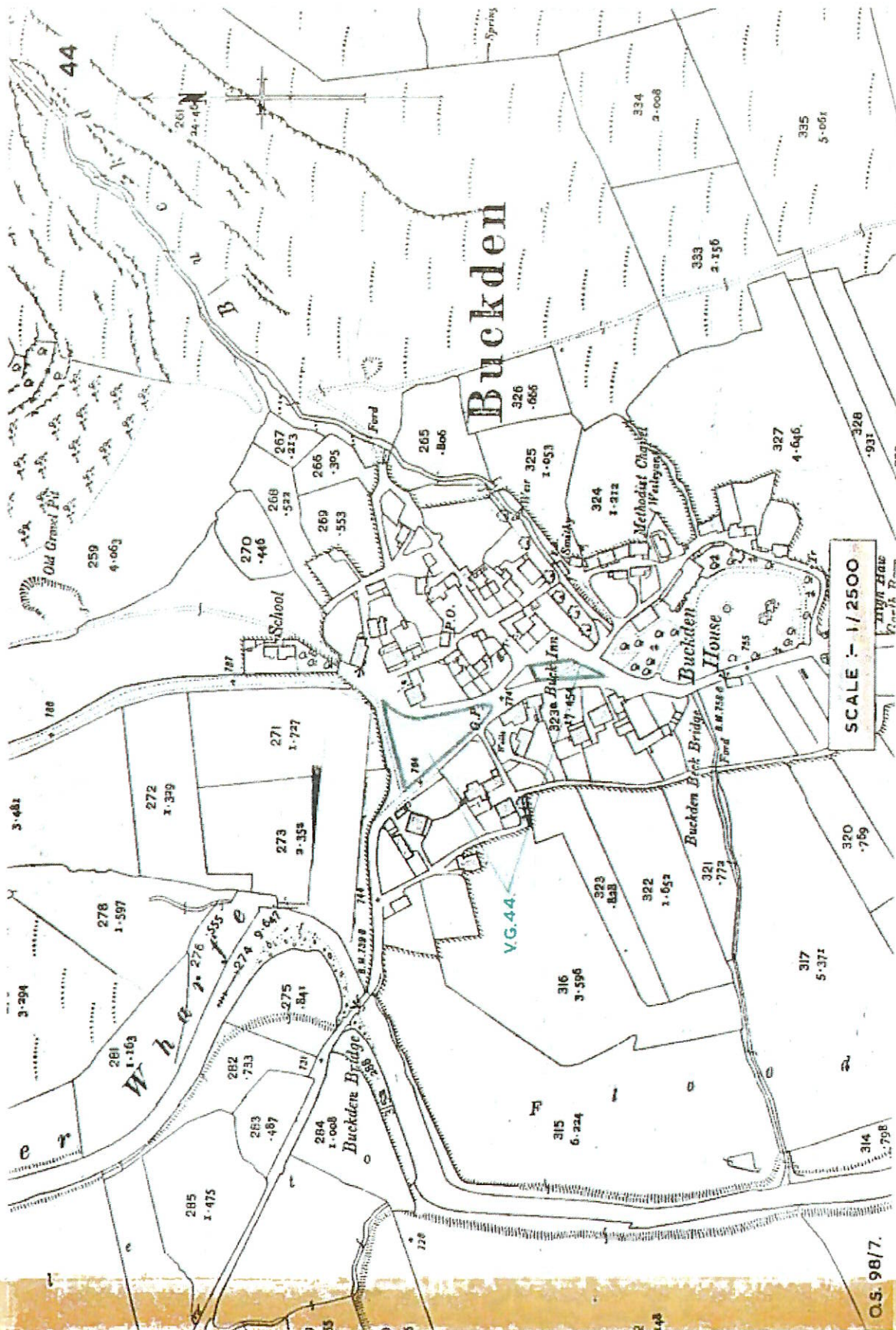




OVERLAY No. 1 FOR V.G. 44. - APPLICATION No. 1923.

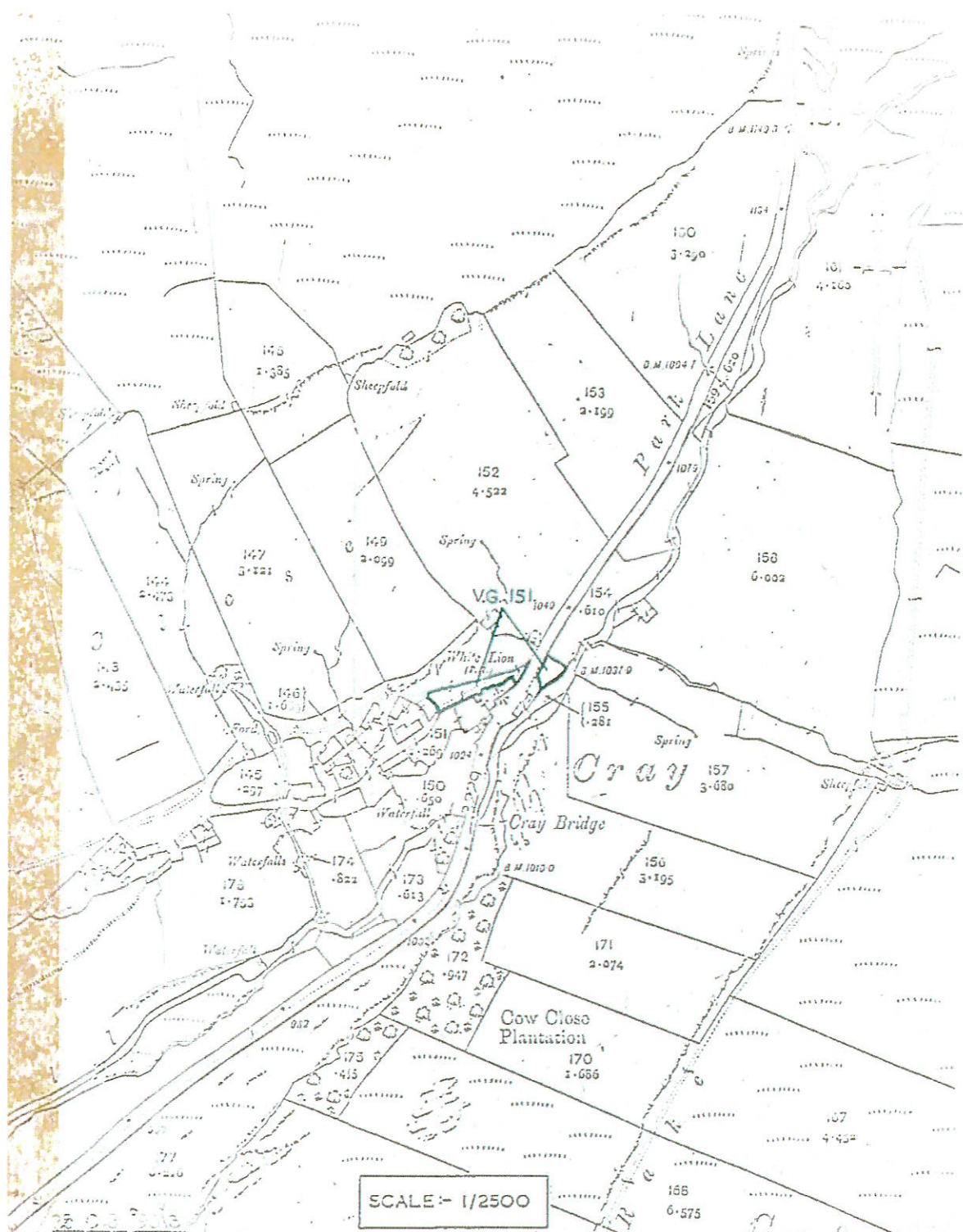
